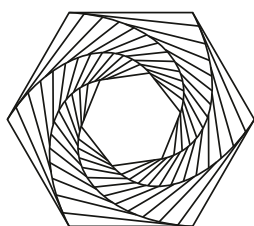

Manchester Society of Architects Design Awards

The awards, held annually since 1995, are presented for buildings that have made a particularly positive contribution to the local environment.

The awards this year will be judged by Lord Foster of Foster + Partners.

The awards evening will take place at Albert Hall at **6.00pm** on **Thursday 13th June 2019**.

How to enter

Eligibility

Submissions for the exhibition and the awards must be designed by a qualified architect or by an architectural practice at least one of whose principals is a qualified architect resident in and/or working within the Greater Manchester area.

Submissions for the built project categories (2,4,6,8) must have been completed since May 2018.

Submission requirements

Final submission date: 12.00pm on Friday 24th May 2019.

The entry must include the completed application form, a CD containing a PDF (A1 landscape at 300 dpi) of your exhibition board, a high resolution JPEG of a representative image of the project and the entry fee. **NOTE – Your entry will be printed / mounted by the MSA. The cost of this is included in the entry fee.**

£95 plus VAT (£114) per entry. Cheques are to be payable to Manchester Society of Architects. **NOTE – Categories 9 and 10 do not require an additional fee.**

Each entry will receive 3x free tickets for the awards evening.

Announcement and presentation of awards

The awards will be presented at an evening reception on **Thursday 13th June 2019 6.00pm** at Albert Hall, Manchester. The Design Awards will be publicised in local and national professional trade journals, the press and other media. Please note that the MSA cannot guarantee the extent of any media coverage.

10 Future Architect of the Year Award (student prize)

Conditions of entry

Eligibility

ARB registered architects or architectural practices, at least one of whose principals is an ARB registered architect resident in and/ or working within the Greater Manchester area.

In signing the entry form entrants are declaring that they are the author/s of the designs depicted. Where projects have been substantially co-authored this should be clearly stated on the display materials and, where appropriate, the permission of the collaborating parties should be obtained before submitting entries.

Entry fee

The entry fee for submissions for project categories 1-8 is £95 plus VAT. Remittance shall be by cheques made payable to Manchester Society of Architects.

Submission requirements

The entry must include the completed application form, a CD containing a PDF (A1 landscape at 300 dpi) of your exhibition board and the entry fee. Also provide an A4 size copy of the display board with the categories listed on the back.

The content of each board submitted is at the discretion of entrants, but should include sufficient information to explain and describe the project design. Entries are not anonymous and the display boards should clearly display the name of the entrant and the title of the project. The Design Awards will be assessed solely of the basis of the display panels; the judges will not make site visits.

All parts of the form to be filled in for this application to be valid.

In the event of project categories being either over or undersubscribed the MSA and the exhibition curators may, at their discretion, create additional sub-categories or combine categories into which entries may be allocated accordingly.

Design awards

Building of the Year

An award will be presented for the Building of the Year, selected from all the category award winners, judged to be the outstanding project in the exhibition.

Category Awards

Awards will be given to the best submissions in each of the 8 project categories.

Criteria for assessment

Entries will be assessed on the extent to which they demonstrate, in the opinion of the judges; fitness for purpose, elegance of design and the contribution they make to the built environment.

Judges

Lord Foster of Foster + Partners will be this year's independent judge.

Publicity

Details of the exhibition and the award winners will be circulated to the local press and to local and national professional trade journals. In submitting an entry all entrants are agreeing that any material they provide can be published by the MSA and other third parties and that any images they have supplied have been cleared for publication by the copyright holder.

Closing date

Final submission date: 12.00pm on Friday 24th May 2019.
